All requests are subject to C4 staff availability.

RENTAL AGREEMENT

I understand that C4 should not be listed as a zero waste partner on any applications, public advertising, or event related material. Event volunteers or staff shall not wear apparel with the C4 logo (including zero waste t-shirts from previous events) or state that C4 is a partner for the event.

I understand that although I may list C4's waste stations on the event permit application under Recycling & Waste Plan, I am responsible for disposal of all waste.

Compost: *Compost must be contracted with a commercial facility. We recommend contacting neighboring facilities like Summit Rolloffs or Vail Honeywagon for your event composting needs.*

Recycle: *Local event recycling is available for free at the Lake County Landfill & Recycling Center located on County Road 6. Items must be sorted according to local guidelines. Please visit our website for a complete list of what materials are accepted:*

I understand that C4 staff will not be available to assist during the event, and all communication and exchange of materials/supplies must occur during normal C4 business hours prior to and after the event. I understand that C4 has a limited number of bags for purchase at \$2 each prior to the event and I have included this request above.

Bags: Liners should be 55 gallons to ensure a proper fit in the bins. Recycle bags should be clear; we recommend [Clear Stream Bags](#). Events utilizing disposal at a commercial compost facility must also use compostable bags that are BPI certified. We recommend the [Clear Stream EcoSafe 6400](#).

I agree to report pounds/quantities and event participation numbers to C4 within 30 days of the event for waste diversion tracking purposes.

I understand that bins must be returned to C4 clean and in their original condition. I will be charged a \$50 cleaning fee (per bin) for any bins returned uncleaned, and a \$100 replacement fee (per bin) plus a \$100 freight shipping fee to recover the loss of any damaged or missing bins.
